Safety Guidelines for Shooters: Do not intentionally shoot arrows into the ground. . Only point bow at intended target. Never nock an arrow until the intended target is clear of other shooters. Stay on designated paths. Look for arrows only after competition is completed for the day. Place a marker, your equipment or one of your group members in front of the target while looking for lost arrows. Adults must supervise children at all times. Draw weight should be such that shooters are able to draw and aim their bow without undue physical discomfort. Always insure that equipment is in good working order.
